Committee members agreed to move Agenda item 4.1) e) Oasis Bins to accommodate the participation of Ben Bell from Keep Swindon Tidy.

4.1) e) Oasis Bins

EP049 The meeting officer shared their screen to show members photographs provided prior to the meeting of the area surrounding the Oasis, including photographs of an overflowing bin, excess litter build up and a large uncovered manhole hidden within long uncut grass.

Ben informs the committee that he has been trying to make contact with Swindon Borough Council about the open manhole and other queries since March 22nd but has only just received a response with no actual outcome and asked if the Parish are able to assist in anyway? The Chair explained that the Parish do not have responsibility for this area but can assist in chasing it and task the Parish Clerk to pursue with the Ward Councillors and Swindon Borough Councillors to increase the profile of the situation.

ACTION: The Parish Clerk to pursue agenda item 4.1) e) with Ward Councillors and Swindon Borough Councillors.

Ben has submitted a formal requested to Cllr Yeowell that bins be installed either within or around the land surrounding the Oasis and has produced a map of ideal places for the bins to

be located. The Chair suggests an approach me made to Swindon Borough Council and Severn Capital to seek permission for the installation of bins on the site. If the request in denied then to consideration for placing bins around the surrounding area.

Street Furniture

EP057 <u>Noticeboards</u>

Cllr Yeowell informed members that the Manager of Western Community Centre had expressed an interest in installing a noticeboard. The chair requested that the Parish Clerk and Estates Manager make contact to discuss the use of the large remaining noticeboard.

ACTION: The Parish Clerk and Estates Manger to contact the Manager of Western Community Centre to discuss the use of the large noticeboard.

EP058 Litter Bins

a) The removal of a dog bin to be replaced by a full bin located on the corner of Southbrook & Hbuf.

The Chair informs members that the Estates manager has confirmed that this request meets the required criteria and has provided the following costs: Free standing bin - £324+vat Slimline free standing bin - £254+vat Delivery - £60 Installation - £80 On going revenue costs - £98 (per annum)

Committee votes: The vote was unanimous subject to funding being ascertained

 <u>b)</u> The frequency in which the bins are emptied at St Marks Recreation Ground The chair informs members of the costings around increasing the frequency in which the bins are collected, there are 6 bins located at St Marks: Additional collection - £1.83 per bin per collection 212 additional collections - £ 570 (per annum) – (Entirely revenue)

ACTION: That the Parish Clerk and Chair of Leisure & Recreation to consider this item at the next meeting held with a view to either rescheduling or increasing the frequency to resolve the fact that at certain times it is often overflowing.

c) <u>The installation of a replacement bin on Whitehouse Road located just before the bridge</u>

The Chair informs the committee that the bridge is the boundary for the Parish and Highways. A suitable location would need to be looked into.

Committee votes: The vote was unanimous providing a suitable position can be sighted.

ACTION: That the Vice Chair, Estates Manger and Idverde attend the site to seek a safe and suitable location for a bin to be installed.

<u>d)</u> <u>The installation of a new bin located at the Pinehurst Road end of the Cycle track</u> <u>running between Gorse Hill & Pinehurst</u>

The Chairs informs members that the Estates Manager agrees that this request falls within the criteria and that the existing bin that is due to be replaced from HBUF could be re located here

e) Oasis Bins

The Chair informs the committee that the Estates Manager has visited the site and confirms that it does meet the required criteria for bin installation and has also provided the cost of the purchase, installation and collections. The site is currently owned by Severn Capital and would need to seek permission for these to be installed.

It is agreed that there are two areas to be ascertained:

- 1) Where the bins can be installed legally
- 2) Funding Ward allowance or Parish spend?

The Committee votes: The vote was unanimous with the provision that the above can be ascertained
