- a) Cllr Beale has requested that a bin be situated between the Charlton Close and Cricklade Road footpath.

- b) A resident of the Rodbourne Cheney Ward has requested that a bin be situated within the open space enclosed by North Leaze Close in Rodbourne Cheney.

Members agreed that this placement is suitable for a bin, subject to funding the purchase and ongoing revenue for collections.

The Estates Manager confirmed that the bench in St Marks Rec had been replaced.
